

2026 WATER & WASTEWATER RATES

Rate increase effective date April 1, 2026

The City of Houston adjusts water and wastewater rates each year on April 1 as required by City ordinances. These adjustments may include:

- An automatic inflation adjustment based on the Houston-area Consumer Price Index. The inflation adjustment for April 1, 2026, is 1.37%.
- Scheduled rate adjustments adopted through the City's 2021 Water & Wastewater Cost of Service Rate Study (Rate Study) (Ordinance No. 2021-515), which established a five-year plan to ensure the utility system can continue to operate, maintain and improve critical water and wastewater infrastructure, protect the financial integrity of the utility system, and meet other system obligations. The Rate Study adjustment for April 1, 2026, is 6.5%.

Starting April 1, 2026, the average rate increase across all customers will be 7.87% for combined water and wastewater service.

Please note this does not mean all customers are receiving a 7.87% increase on their bill. Each customer's adjustment is calculated based on their customer category and usage. To calculate your estimated new bill visit www.HoustonWaterBills.org. New rate tables will be posted on April 1, 2026.

What You Need to Know

As Houston continues to grow, we must provide water and wastewater services to our valued customers. These rate adjustments are necessary to address increases in the costs of operating, maintaining, repairing, and expanding the combined water and wastewater utility system; pay debt service on the utility system's bonds and other obligations; protect the financial integrity of the utility system; and comply with certain bond covenants and all other applicable law.

2026 WATER & WASTEWATER RATES

Effective date April 1, 2026

The monthly service charge for both water and wastewater is affected by the water meter size. For all classes that include wastewater, the water consumption is used to determine the appropriate wastewater consumption charge. TCEQ fee is a fixed monthly charge of \$0.21 per connection to the public water system.

Single-Family Residential: Single-Family Residential:

The monthly meter charge for each meter size is listed below. For simplicity, this table adds volume and base charges together for 1,000 to 6,000 gallons. From 7,000 to 12,000 gallons the rate is \$12.54 per 1,000 gallons, regardless of meter size. Starting at 13,000 gallons, the rate is \$15.82 per 1,000 gallons. Over 20,000 gallons, the rate is \$20.20 per 1,000 gallons. TCEQ fee is a fixed monthly charge

Industrial program fee is a fixed \$1,230.98 charge to customers with an industrial wastewater program permit.

Other Classes:

Industrial w/Surcharge:

Industrial rates include a monthly meter charge and volume charges for both water and wastewater. Some customers are billed for wastewater only, based on readings from non-City of Houston water meters. These customers take their water from non-City of Houston sources and may choose to install a water meter of the type and standard approved by the department for the purpose of measuring the amount of water taken into such facilities. The water consumption indicated by such meter shall be the basis of determining the Wastewater charge. Rates are the same as if the water is from City of Houston source.

No consumption is included with the Monthly Meter Charge for water or wastewater. While the Monthly Meter Charge for water and wastewater is determined by meter size, the volume charge for wastewater may vary based on the results of effluent testing. Industrial program fee is a fixed \$1,230.98 charge to customers with industrial wastewater program permit.

 - Area 1 & 2 = \$3.79 (80.12%)
 - Area 3 = \$2.78 (58.77%)
- Q is the quantity of groundwater produced by the GRP participant during the month.
